



## 2024 HERO SERIES

### REGULATIONS

The set of races 2024 HERO SERIES is made up of 3 MTB Marathon races taking place in Italy/Dolomites, Germany and Switzerland.

- HERO Südtirol Dolomites, Italy
- Black Forest ULTRA Bike Marathon, Germany
- Iron Bike Marathon, Switzerland

The 3 races are adding up to a distance of 287 km and 11.180 hm.

## 2. REGISTRATION

The participants can register exclusively online on the Datasport Portal through the registration portals of the organizers of the three marathons until 10<sup>th</sup> June 2024. Participants can register for the race package of 3 races at the following prices:

Early bird registration until 30<sup>th</sup> June 2023 € 205,00

From 1<sup>st</sup> July until 30<sup>th</sup> September 2023 € 222,00

From 1<sup>st</sup> Oktober until 31<sup>st</sup> January 2024 € 230,00

From 1<sup>st</sup> February until 10<sup>th</sup> June 2024 € 256,00

Teams who register 10 participants get 2 free registrations. A team must have at least 4 members. Team registrations must be sent to [info@herodolomites.com](mailto:info@herodolomites.com).

The starting blocks are established by each race according the UCI ranking. The amateurs will start from the first amateur starting block. The UCI delegate, with the agreement of the race chief and jury members, is allowed to change the starting order.

Should a participant acquire a licence at the first race, he must start as a licence driver for the following races. Daily licences can be purchased through the single race organisers.

## 3. CLASSES AND RANKINGS

Ranking will be established according the following classes:

IMPORTANT: Only participants who have met the following requirements are considered for the ranking:

- Obligation to participate in all 3 races
- 3 results are required, however, in order to be included in the ranking of the 2024 HERO Series, it is necessary to complete the HERO Südtirol Dolomites as a finisher

Ranking points will be attributed according to the following scoring scale:

200 for the 1st	131 for the 7th	110 for the 13th	52 for the 50th

The allocation of UCI points is directly tied to the ranking achieved in each race. Every participant in the HERO Series 2024 will earn points in each race. The overall leader at the end of the three races will be the one with the highest accumulated points. The top 4 participants from each team will be considered for the team ranking. The leaders of both the individual and team rankings will be awarded color-coded starting numbers. The prize-giving ceremony will take place at the culmination of the series during the Iron Bike Marathon on September 22, 2024.

In the event of a tie, the participant with the best ranking in the last race will be declared the leader. It is crucial for every participant to respect the rules of each race, the national cycling union's regulations, and the UCI's guidelines for a fair competition.

Should one or more races of the HERO Series not take place, the entire circuit will be cancelled, and the anticipated prizes will not be awarded.

#### **4. PRIZE**

The leader in the individual classification of the race series will receive the "HERO Series 2024" jersey and will be awarded with the jersey at each stage of the HERO Series. The following cash prizes are provided for the respective categories in the overall standings.

### **5. PROTESTS**

Possible protests must be lodged with the jury at the same time, according to the regulations of the UCI and the local Cycling Federations.

### **6. EVENT CANCELLATION**

The organization committee reserves the right to modify the rules, the routes or the number of positive ascents at any time when circumstances require. The event will be held no matter the weather conditions as long as competitor's security is guaranteed. If the race has to be cancelled in the event of a reason beyond the organization's control, the registration won't be reimbursed or postponed to next year. Every official information will be communicated on the website of the event.

### **7. Modifications**

The organizers reserve the right to make changes to the regulations at any time. The official website of each event is the primary information portal, where all official announcements will be published.

## **8. RESPONSIBILITY**

Mountain biking in general and mountain biking competitions in particular represent a physical activity which involves risks. Each participant must enter the race knowing that he/she will ride on mountainous terrain with steep climbs and rapid descents and doing it on his/her own responsibility. Registration implies that participants give up asserting their rights against a third party, the organization and against every natural or legal person involved in the event. Moreover, with the registration participants prove their good physical conditions to assume a great effort.

## **9. ADDITIONAL PROVISION**

For every case that is not mentioned in the present regulations, UCI and local Cycling Federation rules will be the reference.

## **10. REGISTRATION**

Registration implies that participants confirm:

- to have a medical certificate for the HERO Dolomites in case of disqualification, according to the Italian ministerial decree 18.02.82; besides, the organization does not accept any responsibility in case of accident or health issue
- To have a license issued by a federation authorizing them to take part in cycling competitions
- To have a civil liability insurance
- To have read and accepted the present Regulations

The participants also agree to the use of their images or data, in accordance with the Italian data protection law No. 675 of 31.12.1996. Additionally, the participants give consent that any photo and video recordings of themselves and their child, taken during the event, may be used by the organizing committee (OC) for advertising and marketing purposes in any form.

## **11. DATA PROTECTION**

By sending the online registration form, the competitor must declare to have carefully read and unconditionally accepted the regulations of the HERO Series 2024 as published on the website [www.heroworldseries.com](http://www.heroworldseries.com), in all its parts.

In relation to the information referred to in art. 13 of EU Regulation 679/2016, the competitor must declare that he or she has read the said information published on the website [www.heroworldseries.com](http://www.heroworldseries.com) and that he or she has been informed that consent to its processing for the purposes indicated in art. 2) of the above information is mandatory' by selecting the appropriate box on the registration form (for the purposes of processing personal data), and knowing that failure to consent to the processing of data for the purposes indicated in art. 2) of the information, will make it impossible to register for the activity in question.

With consent to the processing of personal data, the competitor expressly authorises the company that data can be transmitted and processed by third parties. The data must be complete and legible for insurance purposes.

With the consent to the processing of their personal data the competitor expressly authorises the Company, so that the data can be transmitted and processed by third parties that offer related services or services connected to the organisation, as for example the delivery and or sending of gadgets purchased by the competitor, for the purpose of timing, drawing up, announcing and publishing results on the website, and for the purpose of photographing or filming the competitor.

According to art. 4 of EU Regulation 679/2016, processing means *"any operation or set of operations, performed with or without the aid of automated processes and applied to personal data or sets of personal data, such as collection, recording, organisation, structuring, storage, adaptation or modification, extraction, consultation, use, communication by transmission, dissemination or any other form of provision, comparison or interconnection, limitation, cancellation or destruction"*.

In relation to the lists of results and rankings, the publication of photos, videos, audio - and / or video recordings of any kind, the company will use the image of the athlete for internal and external use (various publications, sports films, electronically and on the company website [www.herodolomites.com](http://www.herodolomites.com)). As far as the images and/or video recordings are concerned, the athlete may appear alone or together with other subjects, in the course of initiatives promoted by and for the Company. ## **12.DOPING**

By submitting the online registration form, the participant also certifies, together with their team manager, that there are no sporting sanctions against them due to doping in the civil and/or criminal areas, including those that have been served. They declare that they have not taken or are not taking any substances listed in the World Anti-Doping Agency (WADA) or **NADA** (<https://www.wada-ama.org/en/what-we-do/the-prohibited-list>) prohibited list.

Providing false information is subject to legal consequences. In the event of a positive doping test during the HERO Series races or other sports events, or if positive results and/or sanctions and bans are proven by anti-doping authorities or civil and criminal courts within 15 (fifteen) months after the event, the athlete is obliged

to pay the organizing company a compensation of 50,000 € (fifty thousand euros) for the severe damage to their reputation. If the athlete belongs to a sports club, the club is usually responsible for paying this sanction.
