



HERO SERIES 2022

REGULATIONS

The set of races HERO SERIES 2022 is made up of 3 MTB Marathon races taking place in Italy/Dolomites, Dubai - Hatta and Thailand/Chiang Rai.

Men

BMW HERO Südtirol Dolomites, Italy, 18 June 2022 86 km and 4,500 hm

HERO Dubai Hatta, UAE, 06 November 2022 60 km and 1,600 hm

HERO Thailand, Chiang Rai, 12 November 2022 65 km and 1,800 hm

The 3 races are adding up a distance of 211 km and 7,900 hm.

Women

BMW HERO Südtirol Dolomites, Italy, 18 June 2022 60 km and 3,200 hm

HERO Dubai Hatta, UAE, 06 November 2022 60 km and 1,600 hm

HERO Thailand, Chiang Rai, 12 November 2022 65 km and 1,800 hm

The 3 races are adding up a distance of 185 km and 6,600 hm.



1. CLASSES

OPEN MEN (Elite - Amateur - Under 23)

OPEN WOMEN (Elite - Amateur - Under 23)

2. REGISTRATION

Participants has to sign up online via Datasport website **before 17 June 2022**.

The registration fee is the following:

15.02 - 30.04.2022 Euro 250,00 - USD 286.00

01.05 - 20.05.2022 Euro 270,00 - USD 308.00

21.05 - 17.06.2022 Euro 280,00 - USD 320.00

The starting blocks are established by each race according the UCI ranking.

The amateurs will start from the first amateur starting block. The UCI delegate, with the agreement of the race chief and jury members, are allowed to change the starting order.

3. CLASSES AND RANKINGS

Ranking will be established according the following classes:

OPEN MEN (Elite - Under23)

OPEN WOMEN (Elite - Under23)

IMPORTANT: Only participants who have met the following requirements are considered for the ranking:

- **Obligation to participate in all 3 races**
- **3 results are required**
- **Acquisition of at least 300 points**

Ranking points will be attributed according the following scoring scale:

200 for the 1 st	131 for the 7 th	110 for the 13 th	52 for the 50 th

The allocation of UCI points is linked to the ranking achieved in each race. At the end of the 3 races set, the leader will be the one with more points. Beyond the 100th place, the participant scores 1 point.



The prize giving ceremony will be held after the last stage, HERO Thailand, on 12 November 2022. In case of draw, the best ranking at the last race will determine the leader.

Participation to HERO Series 2022 implies each competitor's respect of the rules of each race, the national cycling union's rules and the UCI's rules.

Should one or more races of the HERO Series not take place, this will lead to the cancellation of the entire circuit. The foreseen prizes won't be awarded.

4. PRIZE

Every class leaders receive the **HERO Series 2022 jersey**. For the ELITE - UNDER 23 class, the ten first will be rewarded with cash prizes according the following scale:

5. PROTESTS

Possible protests must be lodged with the jury at the same time, according to the regulations of the UCI and the local Cycling Federations.

6. EVENT CANCELLATION OR MODIFICATIONS

The organization committee reserves the right to modify the rules, the routes or the number of positive ascents at any time when circumstances require. The event will be held no matter the weather conditions as long as competitor's security is guaranteed. If the race has to be cancelled in the



event of a reason beyond the organization's control, the registration won't be reimbursed or postponed to next year. Every official information will be communicate on the website of the event.

7. RESPONSIBILITY

Mountain biking in general and mountainbiking competitions in particular represent a physical activity which involves risks. Each participant must enter the race knowing that he/she will ride on mountainous terrain with steep climbs and rapid descents and doing it on his/her own responsibility. Registration implies that participants give up asserting their rights against the organization and against every natural or legal person involved in the event. Moreover, with the registration participants prove their good physical conditions to assume a great effort.

8. ADDITIONAL PROVISION

For every case that is not mentioned in the present regulations, UCI and local Cycling Federation rules will be the reference.

9. REGISTRATION

Registration implies that participants confirm:

- In case of disqualification, to have a medical certificate according ministerial decree 18.02.82; besides, the organization do not accept any responsibility in case of accident or health issue
- To have an license issued by a federation authorizing them to take part in cycling competitions
- To have a civil liability insurance
- To have read and accepted the present Regulations

10. DATA PROTECTION

By sending the online registration form, the competitor must declare to have carefully read and unconditionally accepted the regulations of the HERO Series 2022 as published on the website www.heroworldseries.com, in all its parts.

In relation to the information referred to in art. 13 of EU Regulation 679/2016, the competitor must declare that he or she has read the said information published on the website www.heroworldseries.com and that he or she has



been informed that consent to its processing for the purposes indicated in art. 2) of the above information is mandatory' by selecting the appropriate box on the registration form (for the purposes of processing personal data), and knowing that failure to consent to the processing of data for the purposes indicated in art. 2) of the information, will make it impossible to register for the activity in question.

With consent to the processing of personal data, the competitor expressly authorises the company that data can be transmitted and processed by third parties. The data must be complete and legible, also for insurance purposes. With the consent to the processing of their personal data the competitor expressly authorises the Company, so that its data be transmitted and processed by third parties that offer related services or services connected to the organisation, and as for example the delivery and or sending of gadgets purchased by the competitor, those for the purpose of timing, drawing up, announcing and publishing results on the website, and those for the purpose of photographing or filming the competitor.
